Landscape Contract Renewed for Two Years

Association trustees reviewed the work performed by Bohac, Inc. during the past two years under our contract for landscape service. While there are always areas that need improvement, the work done has resulted in the trustees accepting the two-year option locking in the price with a modest increase. In keeping with our normal policy of bidding work on a regular basis, the trustees will prepare to go out to bid on the landscape contract in the fall of 2005. There are only a handful of contractors who can handle a job the size of High Point, limiting the number and quality of the bidders available.

City Hall Resides in High Point

Many residents know that High Point has been well represented around Strongsville City Hall. Not only is our new mayor, **Tom Perciak**, a long-time resident, but his predecessor, acting Mayor **Ray Haseley** (and our Ward 2 Councilperson) is also a homeowner in High Point. Congratulations to Tom and Debbie on the successful fall election. We look forward to many years of expert and enthusiastic leadership from Mayor Perciak. Many of our residents received their current, as well as many past mortgages from Tom at Strongsville Savings and then Fifth-Third Bank. Your association trustees are in full agreement with the Resolution of Appreciation passed recently by members of City Council and the new Mayor recognizing Ray Haseley for his unselfish dedication and service as acting mayor of our community following the tragic death of Walter F. Ehrnfelt. We are glad to have him back serving full time as our Ward 2 Councilperson. And also deserving mention is mayoral candidate **Tony Zubek**, a long-time resident on Timberline. While Tony was not elected, he represented High Point well in the campaign. One last observation from the trustees is that while **Joe DeMio**, a good friend of our association and a great at-large councilperson, was the runner-up in the election, we are pleased that he will continue on council. Joe has always been responsive and helpful to High Point residents.



Association Dues payable in January

Notices for the 2004 Association Dues were sent out in the mail to each High Point homeowner. You should have received your dues notice in late December. If you did not receive your invoice or have misplaced it, call Bob Campobenedetto at 238-3013 or Ken Evans at 572-3292. Homeowners of record (property owners listed in Cuyahoga County records) are legally responsible to pay dues.

Our By-Laws require that dues be paid January 1 of each year. A grace period is authorized by the trustees for payments received during January. Payments made after January 31 (determined by postmark date) are subject to a late fee of \$25 per calendar month, until paid. Beginning January 1, 2004, High Point dues are \$330 per year. If a homeowner has financial or special difficulties, please call a trustee listed above. **We appreciate homeowners who pay their dues on time each year.**

High Point trustees cannot recommend contractors or service providers, however those listed above did excellent work at a reasonable price. Should homeowners require similar services in their personal or business activities, it might be a good idea to solicit a bid from these local contractors along with other proposals that might be obtained.

Notes to 2004 Financial Statements

Two financial reports appear in this newsletter. First is a "Budget vs. Actual" recap of revenue and expenses for the 2004 calendar year. You will note there are a number of budget items that are over budget and some that are below. Trustees do their best to project revenue and expenses, using past years and forecast formulas. Sometimes we do better than others. Most obvious is the overspend on the Clubhouse project. This is a bookkeeping situation where a portion of payments to the contractor was anticipated in 2004 and came early. Association trustees borrowed funds against 2004 revenue to cover the expenses. A number of mechanical repairs in the pool took us over budget and we also were higher in clubhouse supplies which were related to the clubhouse project. Thanks to contract negotiations, our pool management cost was under budget. Interest revenue was also under budget.

Our ten-year rolling budget reflects the final actual numbers for 2003. While we finished with the High Point 2000 series of capital improvements, you can see several renovation and replacement projects are planned over the next few years to keep our facilities in premier condition. One special note to the ten-year review is the \$60,000 loan is shown as income for 2003 and repaid in 2004 as an expense. Questions about any financial item can be directed to the trustees or raised at the annual meeting.

Strongsville Associations Meet in February

Several years ago the High Point trustees began hosting informal meetings with trustees of other homeowner associations in Strongsville. That practice has continued because developments face common problems. Your trustees have discovered a wealth of information by exchanging ideas with trustees from other associations. On February 25, trustees from associations all over our city have been invited to gather at High Point to have roundtable discussions on many important issues.

Next Newsletter in early May

Association trustees will send the next newsletter out with information on pool pass registrations and operating hours in early May. Continuing the process of keeping postage costs down by only sending three newsletters a year, the trustees encourage residents to keep up to date using our website.

High Point residents are governed by Covenants and Restrictions. If you plan to remodel or add to your home this summer, it is necessary to first contact the homeowner association. An Architectural Review form must be completed and submitted to the trustees for approval. City departments will not approve plans until they receive approval from the association. Forms are available on our website or by calling the Homeowner Hotline at 440-238-1580. Save yourself time and come to us first.

Club House rentals booking now

As a homeowner, you may rent our club house for private parties. Dates for 2004 are now booking quickly. To determine available dates, go to our website and click on "Clubhouse Rentals" in the left margin. Then click on "View Calendar" in the upper right. You will see the rental calendar and can check what dates are available. Call the High Point **Homeowner Hotline**, **238-1580**, with your date request. Dates are booking quickly. Your call about a rental will be returned within a few days.

<u>Summer rentals</u> are \$200, which includes the cost of lifeguards. <u>Summer parties using the pool may start as early as 5:00 p.m.</u>, with parties sharing the pool with High Point residents during homeowner hours. When the pool closes to residents at 10:00 p.m., parties have the pool to themselves. <u>All parties MUST END BY MIDNIGHT - 12:00 A.M.</u> Clean-up must be completed and the club house locked up by 1:00 a.m. <u>Summer pool rentals</u> may also be done from 5:00 p.m. to 10:00 p.m., where the cost is \$125. Another option is available for a <u>NON-POOL rental</u> for \$125 (anniversaries, showers, retirements, etc.). These can be any time during the day or evening. Call for more information on any of these options.

A refundable security deposit of \$300 is required and returned if no damage is done to the club house. Rental dates are confirmed only when separate checks (rental fee and security deposit) are received, a rental contract has been signed by the homeowner, and a "Release From Liability and Agreement to Indemnify" form has been executed. **Residents who rent the club house are responsible for cleaning the facility when they are done, removing all trash and debris, taking down decorations and tape, vacuuming the floor, and putting tables and chairs away.**

Club House rentals are a privilege reserved for High Point residents only and not friends, other relatives or the general public. Activities are limited to family entertainment and recreation, unless otherwise approved by the trustees prior to a contract being signed. Residents renting the facility must be present at all times and are responsible for the conduct of guests and any damage. Inspections of the facility are done before and after each party. *Fire code capacity is 120 people*.

Election Ballot for Association Trustee

Two positions on the Board of Trustees are available for a two-year term that runs from January 2004 to December 2005. There are five trustee positions, with David Knowles, Jack Schneider and Mark Skalak now serving a two-year term that began in January of 2003. Three homeowner names appear on the ballot for two trustee positions. (*Please note the October 2003 newsletter incorrectly reported three trustee positions would be on the ballot. We apologize for this error.*) In this election, the two candidates with the highest number of votes will be elected. Ballots may be mailed to the association post office box or delivered in person by the deadline of the Association Annual Meeting at the club house on **Wednesday, January 28 at 8:00 p.-m.**

Homeowners should vote for **no more than two** candidates and mail it to the address above no later than January 24 or bring it to the Annual Meeting on January 28.
