2011 Clubhouse Rentals Booking Fast

If you look at the up-to-date 2011 rental calendar on our website for Clubhouse rentals, you will find many dates already rented. If you have a graduation, anniversary, shower, wedding reception or other event you are planning, we suggest you reserve your date as quickly as possible to get your choice. Check the website and call the Homeowner Hotline (440-638-4304) to make your reservation.

Summer rentals using the pool *until midnight* (private use from 10:00 pm to midnight) are available for **\$250** for the summer of 2011. Clubhouse rentals (with or without pool use) where the party ends at 10:00 pm will still be \$125. A security deposit of \$300 (one check for \$50 and one for \$250) is required. Signups are done at the clubhouse and checks for the rental are submitted at that time.

GIVE KIDS A BRAKE!

Even in the winter, drivers in High Point need to be aware and careful. Snow mounts and winter road conditions make driving (especially at night) hazardous for kids and pedestrians. While everyone is in a hurry during the holiday season, we ask you to take your time as you drive through High Point. Be aware in the mornings as kids wait for school buses. Financial Review Completed for 2009

A financial review of the 2009 calendar year was completed this summer by Jurcago & Company, a local CPA firm. Report copies are available on request. This report details continued safe and sound business practices. Although not an audit, the review addresses four major items: 1) reconcile cash on deposit as of 12/31/2009; 2) test dues and rental income as reported; 3) review disbursements for proper payment and classification as reported on statements; and 4) check financial statements as of 12/31/2009. This protects residents so they can be sure funds are on deposit and used appropriately. Questions may be directed to Bob Campobenedetto (238-3013) or Ken Evans (572-3292).

For Your Personal Sledding Safety

Sledding is not allowed on common property. As hills in the common area are too small for this activity and are close to homes, it is dangerous and can easily cause property damage.

Our association is fortunate that Southwest General Health Center allows sledding on the mounds that buffer our development. Sledding is allowed on the slope facing the health center (not on the High Point side). This is a large area which can accommodate a large number of people. **As with any activity of this type, parents should be present with kids under 12**. *Please note those going to this area should NOT cut through yards to get to the mound*. Ample parking is available to drive and park behind the Health Center. We appreciate this generous arrangement by SWGHC officials.

Neighborhood Safety

During the winter season, many visitors come into our development. Some are invited and some are not. Be on the lookout for activity that does not look right and call police. If neighbors are on vacation and you see someone in the house, it is usually a bad sign. If you see or hear people roaming the area late a night, a call to the police is also warranted. Vandalism, damage and theft all usually take place a night, under the cover of darkness. Look out for your neighbors and call police when you see something that does not look right. Police would rather respond to false alarms than not be called and complete crime reports later on. Also make sure your front post light is working to light the night.

Retention Lake Safety

High Point residents are reminded that the two retention lakes in the development are NOT intended for recreational activities, including ice skating. These bodies of water are designed for the purpose of detaining runoff water from the development and surrounding areas. It is especially important to understand that these lakes do not easily freeze and should NEVER be used for ice skating.

Swim Passes Ordered with 2011 Dues

Attention residents! Pool pass registration forms for next summer will be distributed with the Dues Invoices. Pool Pass Registration forms for 2011 MUST BE RETURNED WITH YOUR DUES PAYMENT BY JANUARY 31. We will not have spring pick up times or fill orders during the summer. This past year, association trustees spent considerable time filling pool pass requests throughout summer months. Most other homeowner associations handle pool passes with a similar advanced registration procedure. 2011 Passes will then be mailed first-class to residents the first week in May. (We will supply the postage and label – no self-addressed, stamped envelope is necessary.)

IF YOU EVEN THINK YOU MIGHT WANT TO USE THE POOL IN 2011, then you should order pool passes with your dues payment. You have already paid for these in your dues. We know there are many homes for sale in the development, and in the event your home is for sale and sells before or early in the summer, new residents will have the opportunity to get pool passes at that time.

AGAIN IN 2011 – If you do not order your pool passes before May 1, 2011, you will pay a \$10.00 late order fee (which the trustees will donate to the High Point Swim Team) to get your passes. As trustees, our time is valuable and when pool pass orders are filled during the spring, it is done at times that are convenient for board members. After May 1, everyone wants their passes right away and the element of convenience is no longer available. Please order your 2011 pool passes with your dues payment and you won'thave to worry about the fee.
